The Good Food Collective fund, based in Durango, was able to purchase their own building this year providing them a secure and permanent home for their programs! Onward! will use a small space in the office for our new Onward! Durango Program Hub thereby providing more support for all of our funds operating in La Plata county.

Then, in October, Onward! was the recipient of the largest gift ever given to the foundation – the donation of 155 acres in McElmo canyon, a property with large warehouses, other buildings, water and irrigable farmland! This will be the home of our Pueblo Seed and Grain Hub serving farmers in the Southwest region. It will have commercial grade seed cleaning equipment available for farmers, it will become a regional seed bank for Heritage seeds and provide experiential learning opportunities. 

#### **ENDOWMENT FUNDS**

## THE CORTEZ PUBLIC LIBRARY ENDOWMENT FUND

Established: November 2002

Purpose: Provides permanent support for specific library needs, children's programs, and annual subscription costs through private donations.

#### THE SEARLE COMMUNITY ENDOWMENT FUND

Established: October 2003

Purpose: Originally established by Citizens State Bank in honor of their past president, Charles Searle. The fund now awards annual grants to programs or organizations benefiting the region as a whole.

#### **GENERAL ENDOWMENT FUND OF ONWARD!**

Established: September 2009

Purpose: Provides permanent funds for grants and the general operation of the foundation. The yearly grant cycle runs from September 1st to October 15th, with numerous grants awarded throughout the community in November.

#### **KSJD ENDOWMENT FUND**

Established: October 2016

Purpose: Supports bringing news, arts, and entertainment programs to KSJD and the Sunflower Theatre.

#### WHAT IS AN ENDOWMENT FUND?

Endowment funds manage assets in perpetuity and distribute the earnings annually to the beneficiary non-profit or scholarship.

The principal amount of gifts and bequests that are accepted are subject to a requirement that the principal be maintained intact and invested to create a source of income for a specific purpose. Endowment funds managed by Onward! earn market rates of return.

### What is a Donor-Advised fund?

Donor-Advised funds allow donors the most flexibility to achieve their charitable purposes and are a simple alternative to a Family Foundation. Create a donor-advised fund with Onward! A Legacy Foundation's help to navigate the process. With six easy steps, your legacy can make a mark in our community.

- 1. Make a gift of cash, securities, real estate or other assets to Onward!
- 2. Onward! creates a special fund in your name, or the name you select
- 3. You receive a tax benefit in the year your gift is made
- 4. You recommend uses for the fund
- 5. Onward! ensures that recipients of the fund are IRS-recognized nonprofits in good standing
- 6. Onward! handles the administrative details and pays grants to charities in the name of your fund



## GOOD FOOD COLLECTIVE

#### BUILDING OUR REGIONAL HUB



The Good Food Collective is a nonprofit organization based in Durango, Colorado, working to strengthen the regional food system through efforts to address food security, food justice and equity, and the regional food economy. The organization works in deep partnership with stakeholders across the food system to build a just and resilient regional food system in Southwestern Colorado, believing that an intact regional food system creates economic opportunities for rural areas, creates jobs, stewards the environment, ensures that everyone in the community has access to nutritious, dignified food, and builds the backbone of a vibrant community.

The Good Food Collective is currently focused on three core areas: Agricultural Support, Regional Convening, Coordination & Support, and Food Security and Health

Equity. The organization addresses food system challenges through systems-based approaches that consider the needs of the entire region through meaningful partnerships and cross-sectoral collaboration.

In August 2025, the Good Food Collective purchased a 2,500-square-foot facility in Durango—our first permanent home and, importantly, a regional hub shaped by community and partner input. With renovations, this building will house a flexible convening and teaching space, a childcare nook, a shared office hub with technology access, and critical food storage infrastructure. Statewide food hub leaders have identified our region as an essential "node" in Colorado's distribution loop, and this facility will enable our producers and pantries to link more effectively into statewide markets and networks.

This facility will be more than bricks and mortar—it will serve as a regional hub shaped by stakeholder input, designed to connect people, strengthen supply chains, and elevate voices that are too often left out of systems-building work. By co-locating

meeting, childcare, technology, and storage infrastructure, we will create opportunities for dialogue, coordination, and innovation that extend across southwest Colorado and link to statewide networks.

### What is an agency fund?

Agency funds are created by non-profit 501(c)(3) organizations with Onward! for managing long-term funds.

These funds give organizations the opportunity to save dollars in a professionally managed fund that can generate investment income, year after year, but also remains fully accessible with a vote of the nonprofit's board. A portion of the earned income can be drawn down in set annual payments or reinvested in the fund to grow over time, according to the organization's needs. It's a flexible, simple way for nonprofits to build funds for a project or future operational needs. Agencies can also choose to create an endowed fund to maintain a principal balance for the future.

## WHAT IS A SPECIFIC INTEREST FUND?

Specific interest funds can resemble other funds with Onward!. A specific interest fund can be set up by a donor to support his/her favorite non-profit organization over time. While a donor advised fund gives flexibility as to the recipient year to year, specific interest funds are designated to carry out the donor's specific wish annually.

Specific interest funds can also bring together a group of people to support a charitable interest in our community without creating a new 501(c) (3). Examples of this include the Ute Mountain Roundup Reserve Fund, and the various friends of the library funds.

## SPECIFIC INTEREST FUNDS

#### **ONWARD! GENERAL FUND**

Established: April 2002

Purpose: Used for the operations of the foundation. It is unrestricted and the income is generated from the annual 1% management fee assessed on the invested funds and management fees of fiscal fund sponsorship.

#### **DOLORES PUBLIC LIBRARY FOUNDATION**

Established: July 2004

Purpose: Supports specific library needs and programs at the Dolores Public Library. The fund was established in memory of Clifford C. Fossum, a local citizen who was an avid supporter of the Dolores Public Library.

## MONTEZUMA COUNTY SHERIFF'S OFFICE EMPLOYEE FUND

Established: November 2007

Purpose: Assists the sheriff's office employees in the event of a tragedy or major medical situation. The fund is funded by private donations.

#### THE FRIENDS OF THE CORTEZ LIBRARY FUND

Established: January 2008

Purpose: Provides additional earnings to the Friends group, which in turn provides support to the Cortez Public Library.

#### THE UTE MOUNTAIN ROUNDUP RESERVE FUND

Established: August 2009

Purpose: Creates a reserve fund for future capital improvements at the Montezuma County Fairgrounds.

#### THE MANCOS LIBRARY FOUNDATION FUND

Established: June 2012

Purpose: Support specific needs and programs at the Mancos Public Library and was created by library patrons.

#### **COX FAMILY CHARITABLE REMAINDER TRUST**

Established May 2018

Purpose: Onward! manages this trust for the beneficiaries.

Established February 2019

Purpose: Establishes charitable giving from the employees of Axis Health System via employee committee review during the Onward! grant cycle.

### PUEBLO SEED AND GRAIN HUB

#### A NON-PROFIT INITIATIVE DEDICATED TO HEAT AND DROUGHT TOLERANT

#### GRAINS & LEGUMES IN SOUTHWEST COLORADO

The goal of this project is to develop key infrastructure and training, education and technical assistance to support the production of heat and drought tolerant food and cover crop seed in order to adapt regional agriculture to hotter, drier conditions and feed people more nutritious food.

#### The objectives are:

- Seed Repository, Cleaning & Testing: Establish & operate food-grade seed cleaning line, seed repository, and laboratory for small and mid-scale organic farmers and food businesses in Colorado, the Four Corners region, and the greater Southwest
- Demonstration Gardens: Develop & maintain small plot gardens for trialing, training & educational and pollinator habitat purposes
- Outreach: communicate with farmers and organizations in Colorado, the Four Corners region and the greater Southwest to promote services
- Seed & Food Literacy: Create and disseminate educational initiatives and materials aimed at introducing nutritious, drought tolerant seed and food into food systems of Colorado, the Four Corners region and the greater Southwest.



#### Background

Hobbs & Meyer, LLC DBA Pueblo Seed & Food Co. is a vertically integrated family farm located in Southwestern Colorado. The Pueblo Seed & Food Co. farming operation has been certified organic since 2001 by the Colorado Department of Agriculture and specializes in open-pollinated vegetable seeds, varietal garlic and heritage grains and legumes. The central focus of the business is to grow adapted, open-pollinated seed to produce nutritious and flavorful food to improve people's diets in Colorado and beyond. Value-added activities, such a milling, baking, freezing, dehydrating and cooking, take place in a Bakehouse in downtown Cortez. In 2022-2023 the business purchased a food-grade seed cleaning line and started a fund with the Onward! Community Foundation to advance charitable and educational work pertaining to seed and food.

Pueblo Seed & Food Co. will continue to operate its for-profit seed and food work as a separate enterprise but is donating its seed cleaning equipment to Onward! to set-up and operate the Pueblo Seed & Grain Hub on a nonprofit basis. Pueblo Seed & Food Co. also intends to eventually donate its seed collection to Onward!.

#### Value Proposition

Organic, drought tolerant heritage grains and cover crops are in extremely short supply in the U.S. (Hubbard et



al. State of Organic Seed, 2022). Infrastructure to support the regional production of these crops is non-existent. Pueblo Seed & Food Co. will establish and operate a non-profit Seed & Grain Hub as a project of Onward! at the Foundation's property located at 19891 Road G. Cortez, Colorado, in order to provide essential services to family farmers and expand the availability of adapted seed and consumption of healthy food in Colorado, the four corners region and greater Southwest. Seed cleaning and testing services will be operated on a fee-for service basis. Outreach, demonstration gardens, educational services to build seed & food literacy will be operated through charitable contributions and grant funding.



#### **FISCAL FUNDS**

#### SCHOOL COMMUNITY YOUTH COLLABORATIVE

Established: December 2010

Purpose: SCYC is a youth serving organization that supports connection, youth leadership, communication and community. We are a prevention-based organization that supports youth through out-of-school time programming, substance use prevention programming, and safe driving education.




